PUBLIC NOTICE

I, Don Davis, Judge of Probate in and for Mobile County, Alabama do hereby certify that the following notice outlines changes that have been made to the voting precincts in Mobile County, Alabama via prior resolutions of the Mobile County Commission and as approved by the United States Department of Justice. Said changes may involve renumbering of precinct locations, establishment of new precinct locations, elimination of certain precinct locations, or changes to precinct boundaries. These changes were prompted by several factors: the voting center was too small; the voting center was too large; there was difficulty in recruiting poll workers; the convenience of voters in traveling to voting center; and inadequate facility considerations. The following is a listing of the new voting center numbers and locations.

Notice is further given that prior to the June primary election, each active, registered voter in Mobile County will receive a postcard from the Mobile County Board of Registrars which will identify the voter's new precinct information.
