In Alabama's government system, Alabama's judges of probate are the custodians of the public records of their respective county. The Alabama legislature, in the 2023 general session, *expanded* the categories of *government officials* and *government employees* who can request redaction of personal identifying information in public records. This statute addresses all personal information in all government offices located in the State of Alabama.

The Act further specifies that government offices are to make available a request form that allows an eligible person to request redaction. One of the Probate Court's forms is attached. I note and call to your attention that the Court only has responsibility for the public records that are in its custody. There are many other governmental entities that may contain personal information regarding public officials and public employees. These offices should be contacted directly to request redaction of information in their records.

Separate and apart from *Ala. Act* 2023-506, ALL persons who live in Mobile County or own property or operate a business located in Mobile County are reminded that *any person* has the ability to register on the Court's Internet web site and request being notified by electronic mail if any document is filed in the Court's public records operation concerning said person. This special feature of the Court's Internet web site has been available for several years and we have published notice of the availability of this feature in the past, but few persons have taken advantage of this feature.

Due to the increase in instances of identity theft, I encourage your to share information about the aforesaid means by which persons can protect their persona I information and guard against identity theft.

(Ala. Code §41-13-7 and §41-13-7.1 (1975))

Please note that pursuant to Ala. Code § 41-13-7 (1975) the Probate Court is not authorized to redact documents originating with any court or taxing authority, any document that when filed by law constitutes a consensual or nonconsensual lien or security lien or security interest, or any record of judgment, conviction, eviction, or bankruptcy.

A qualifying position under Ala. Code §41-13-7(1) includes: any person who is regularly employed by the state and who is subject to the provisions of the state Merit System or any person who is regularly employed by a criminal justice agency or entity or by a law enforcement agency within the state or any honorably retired employee thereof, to include, but not be limited to, the following: A judge of any position, including a judge of a municipal court; a district attorney; a deputy district attorney; an assistant district attorney; an investigator employed by a district attorney; an attorney, investigator, or special agent of the Office of the Attorney General; a sheriff; a deputy sheriff; a jailor; or a law enforcement officer of a county, municipality, the state, or special district, provided the law enforcement officer is certified by the Alabama Peace Officers' Standards and Training Commission and is not pending decertification.

A qualifying position under Ala. Code §41-13-7.1(2) includes: a judge of any position, including a judge of a municipal court; a district attorney; a deputy district attorney; an assistant district attorney; an investigator employed by a district attorney; an attorney, investigator, or special agent of the Office of the Attorney General; a sheriff; a deputy sheriff; a jailor; or a law enforcement officer of a county, municipality, the state, or special district, provided the law enforcement officer is certified by the Alabama Peace Officers' Standards and Training Commission and is not pending decertification; and federal officers and employees in equivalent positions.
