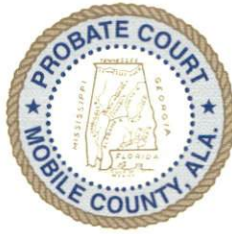

Don Davis, Mobile County's Judge of Probate and Chief Election Officer, announced that on November 12, 2024, the Mobile County Election Canvassing Board processed approved provisional ballots, tabulated write-in ballots cast for constables, and certified Mobile County's 2024 General Election results. Some notable facts relating to this election are:

Mobile County's Reported Population: 411,882

Mobile County's Registered Voters: 322,509

Number of Voters Who Participated in Election: 176,019

Mobile County Voter Turnout Percentage: 54.6%

Year of Mobile County's Highest Percentage Voter Turnout in a Presidential Election and Contest:

1992 General Election Total Percentage Turnout (Clinton vs Bush): 80.02% (Active Voters Only)

Year of Mobile County's Highest Voter Turnout In A Presidential Election and Contest:

2020 General Election Total Votes - 183,803 (Biden vs. Trump) Percentage: 58.4% (Registered Voters)

Mobile County Voters For Donald Trump: 100,759

Mobile County Voters for Kamala Harris: 72,055

Mobile County Voters For Shomari Figures: 55,910

Mobile County Voters For Caroleen Dobson: 47,173

Mobile County Voters For Barry Moore: 53,432

Mobile County Voters For Tom Holmes: 17,379

Mobile County has 80 election precincts. Alabama law provides for one constable to be elected in each election precinct. It is a long-time common practice in Mobile County for constable positions to be determined by write-in votes. Write-in votes have to be manually counted. Mobile County utilized 20 of our 1122 poll workers from across Mobile County to canvass the write-in ballots on the morning of November 12, 2024. In 7 of the constable contests, candidates received the same number of votes. *Ala. Code* § 17- 12-23, provides that in the instance of a tie vote, the judge of probate determines the election by casting lots in the presence of the candidates. Mobile County Probate Court is in the process of contacting these candidates to schedule these meetings.
